We invite you to join us for our 7th community market. The Distillery Market series is a semi-annual community celebration featuring a vendor fair, access to the distillery tasting room and more. Our vendors are hand-picked and represent the small businesses and artisans of our community.



Parties interested in being a vendor inside the Distillery building must complete our application form below and pay a \$30 registration fee by Wednesday, December 1st. Our registration fee covers the cost of electricity (available to all vendors), set-up the day before with alarmed protection for your merchandise, heavy paid marketing promotion of the market, and music entertainment during the event.

THE DETAILS

Where: The Grant Building at the Distillery, 201 North Madison Ave

When: Saturday, December 4, 2021
from 10:00 a.m. - 3:00 p.m.

- Setup Friday 12/3 (call to schedule) or Saturday 12/4 beginning at 9 a.m.
- Building is locked and alarmed overnight for safe storage
- Spaces are 10' x 10' (13 available)
- One 6' banquet table and 2 chairs provided for each space
- Vendors required to apply by 12/1 with a \$30 registration fee

- Vendors must have sales tax certificate on hand
- May bring additional tables, chairs, clothing racks, etc. but must stay within designated space
- Vendors must set-up, take down and cleanup their space by 4:00 pm.
- Event organizers will advertise to the public; we encourage your support by announcing the event to your followers on social media.
- Free public admission and free parking.
- Food and drink will be available for purchase in the distillery throughout the event.
